

SANDAG Vanpool Program "Redesign Your Commute" 2017 Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN NO PURCHASE OR PAYMENT WILL INCREASE YOUR CHANCE OF WINNING

These rules govern the Redesign Your Commute 2017 Sweepstakes (the "Sweepstakes") being conducted by the San Diego Association of Governments (SANDAG) beginning on March 20, 2017 at 12:00 a.m. PT and ending on March 24, 2017 at 11:59 p.m. PT (Sweepstakes Period).

1. HOW TO PARTICIPATE

There will be two Sweepstakes opportunities. To enter the Sweepstakes, follow one or more of the methods below:

- A. EXISTING VANPOOLER PHOTO FACEBOOK SWEEPSTAKES (Photo Sweepstakes).** Three (3) \$100 gas cards will be awarded during the week of March 20, 2017. Existing SANDAG Vanpool Program participants may enter to win by posting a photo and testimonial of their vanpool on the iCommute Facebook page (@iCommuteSD) starting March 20, 2017. A total of three (3) \$100 gas cards will be awarded.

Only one (1) eligible Facebook photo and testimonial per day will count as an entry. Eligible posts must be posted by 11:59 p.m. PT on Friday, March 24, 2017. A total of five (5) possible entries can be earned during the Sweepstakes Period.

Existing vanpoolers may also enter the Photo Sweepstakes by emailing their video to phoenix.smith@sandag.org. You must include the following the subject line: "Redesign Your Commute 2017 Sweepstakes – Photo Facebook Entry." Each emailed video will count as one entry, five (5) email entries per person during the Sweepstakes Period are allowed (one entry per day). Emailed entries must be received by SANDAG before Friday, March 24, 2017 at 11:59 p.m. PT.

- B. EXISTING VANPOOLER VIDEO FACEBOOK SWEEPSTAKES (Video Sweepstakes).** One (1) \$200 gas card will be awarded during the week of March 20, 2017. Existing SANDAG Vanpool Program participants may enter to win by posting a video of their vanpool on the iCommute Facebook page (@iCommuteSD) starting March 20, 2017. A total of one (1) \$200 gas card will be awarded.

Only one (1) eligible Facebook video per day will count as an entry. Eligible posts must be posted by 11:59 p.m. PT on Friday, March 24, 2017. A total of five (5) possible entries can be earned during the Sweepstakes Period.

Existing vanpoolers may also enter the Video Sweepstakes by emailing their video to phoenix.smith@sandag.org. You must include the following the subject line: "Redesign Your Commute 2017 Sweepstakes – Video Facebook Entry." Each emailed video will count as one entry, five (5) email entries per person during the Sweepstakes Period are allowed (one entry per day). Emailed entries must be received by SANDAG before Friday, March 24, 2017 at 11:59 p.m. PT.

ELIGIBILITY RESTRICTIONS

The Sweepstakes is open to all existing SANDAG Vanpool Program participants who are 18 years of age or older and who live or work in San Diego County. Qualifying vanpools must have eighty (80) percent vehicle occupancy and have an origin and destination in San Diego County, or have an origin *or* destination in San Diego County *and* travel a minimum of twenty (20) one-way miles within San Diego County. Employees of SANDAG, contractors or consultants of SANDAG who are working on any iCommute projects during the Sweepstakes Period, the members of their immediate families (spouse, parent, sibling, or child), and those living in the same household of each (whether related or not), are ineligible to win. This Competition is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.

Participants are required to provide truthful information. In order to claim the prize, SANDAG may require the winners to provide a valid government issued photo identification card along with their complete current mailing address, date of birth, and phone number. SANDAG will disqualify any individuals who do not meet these eligibility requirements.

All photos and videos submitted must represent safe driving practices, and may not display drivers breaking the law, including distracted drivers filming or photographing while driving. Passengers pictured in moving vehicles must be wearing seatbelts.

SWEEPSTAKES AWARD

The Sweepstakes Awards are as follow:

- Photo Sweepstakes: Three (3) \$100 gas cards
- Video Sweepstakes: One (1) \$200 gas card

In the Vanpool Sweepstakes, three (3) \$100 gas cards will be awarded during the Sweepstakes for the photo Facebook Sweepstakes and one (1) \$200 gas card will be awarded during the Sweepstakes. Winners of the Photo and Video Sweepstakes drawings will be posted on the iCommute Facebook page wall (@iCommuteSD) by 12:00 p.m. PT on Monday, March 27, 2017. Sweepstakes Awards will be mailed via registered mail to the individual winners at the home address provided by them after notification of winning. Odds of winning depend on the total number of entries received during the Sweepstakes Period.

2. CONDITIONS

Decisions made by SANDAG management with respect to the Promotions and/or Sweepstakes are final.

The Sweepstakes are governed by and subject to the laws of the State of California and the United States as applicable. All federal, state, and local laws and regulations apply. Void where prohibited by law. Sweepstakes Award recipients will pay all applicable taxes and fees.

By participating in the Sweepstakes, the participant agrees to have their name, voice, and likeness used by SANDAG in any advertising or broadcasting material including, but not limited to, social media relating to the Sweepstakes without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of any Sweepstakes Award. Prior to release of the award to the winner, SANDAG, in its sole discretion, may require the Sweepstakes Award recipient (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless SANDAG, its officers and employees, member agencies, directors, agents, and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from use of the Sweepstakes Award and participation in the Sweepstakes.

The Sweepstakes Awards winners must sign and return an affidavit of eligibility within fourteen (14) days of the date SANDAG sends notification to the winner. If a potential winner cannot be contacted, or fails to sign and return the required affidavit of eligibility and/or liability or publicity release within fourteen (14) days of SANDAG sending the notification of winning, the potential winner forfeits the Sweepstakes Award and a new winner may be selected. Substitute winners will have fourteen (14) days to claim the Sweepstakes Award.

Promotions and/or Sweepstakes participants are only eligible to win one sweepstakes prize every 180 days. Eligible participants may only win one prize in the "Redesign Your Commute" 2017 Sweepstakes, but may enter both the Photo and Video sweepstakes.

Participant agrees to hold Facebook harmless and releases Facebook from all liability with regards to the operation of the Photo Sweepstakes and the Video Sweepstakes. Participant acknowledges that neither the Photo Sweepstakes nor the Video Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook.

By submitting an entry, the Participant grants SANDAG a non-exclusive right and license to post and use his or her submitted photo or video in an unlimited fashion.

The Sweepstakes Awards are expressly limited to the items listed above and there is no substitution, transfer, or cash equivalent, except that SANDAG may, at its sole discretion, substitute an award of comparable value. The winners will be solely responsible for all taxes and all other fees and expenses associated with the receipt and use of the Sweepstakes Awards. SANDAG is not responsible for prize utility, quality, or otherwise.

If for any reason this Sweepstakes cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, incomplete or unintelligible entries, or any other causes beyond the control of SANDAG that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Sweepstakes, or if the Sweepstakes is compromised or becomes technically corrupted in any way, electronically or otherwise, SANDAG reserves the right to cancel, terminate or modify both the Sweepstakes. If due to circumstances beyond the control of SANDAG, any competition or award-related event or travel is delayed, rescheduled, postponed or cancelled, SANDAG reserves the right, but not the obligation, to cancel or modify the Sweepstakes and shall not be required to award a substitute award or recognition.

SANDAG, in its sole discretion, reserves the right to disqualify any person or employer tampering with the entry process or the operation of SANDAG or the websites. Failure to comply with the rules of the Sweepstakes may result in a participant's disqualification and/or forfeiture of any award or recognition. If SANDAG makes a good faith determination that cheating or fraudulent activity has occurred in connection with the Sweepstakes, SANDAG reserves the right to disqualify that participant from winning future promotions and to prosecute and seek damages to the fullest extent permitted by law.
